What is this product?

Product	PRAELIA AIFLNP V.C.I.C. Ltd (the "PRAELIA Fund") is an Alternative Investment Fund addressed to a limited number of persons. The fund is authorized by the Cyprus Securities and Exchange Commission (license number LPAIF119/2018), to operate as an open-ended Variable Capital Investment Company as provided in the Cyprus AIF Law L 124(I)/2018. The fund incorporated as a company under the Companies Law, Cap. 113 on the 02nd of April 2019, with registration number HE396090 in the form of a private company limited by shares.
Objectives	<p>The main investment objective of the Fund is to achieve above average risk-adjusted returns by investing in a portfolio of diversified Investments, including investing in shares of non-listed companies, including start-ups, and making investments in real estate. The Fund may also invest in any other investments and securities that the Directors may determine from time to time in their sole discretion.</p> <p>Adverse impacts of investment decisions on sustainability factors are not considered due to the lack of available information at the moment which prevents a proper like-to-like comparison between investments in terms of the ESG factors and because this limits the range of available investments under consideration and thus reduces diversification.</p> <p>The target market of the Company is global with particular focus on Cyprus, Europe, Eastern Europe and Russia.</p>

What are the risks and what could I get in return?

Risk Indicator



- The risk indicator assumes you keep the product for 5 years as per recommended holding period.
- The actual risk can be significantly higher than the one represented in the Risk Indicator if you cash in at an earlier stage.
- The product is considered as illiquid.
- The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Manufacturer is not able to pay you.
- We have classified this product as 6 out of 7, which is the second-highest risk class. This rates the potential losses from future performance at a high level, and poor market conditions are very likely to impact our capacity to pay you.

 - Market risk that rates the potential losses from future performance at a medium-low level.

³: Above Transaction Cost is calculated on the assumption of portfolio turnover of 15 million euros. If portfolio turnover increase/decrease then the charge will decrease/increase accordingly.

⁴: Expert advisor fee is calculated on the fund net asset value.

⁵: Performance of 5% over the hurdle rate of 8% and over High Water Mark in performance period.
